

# SCHOLARSHIP RECIPIENT CHARTER ALLIANCE FRANÇAISE DE PARIS

As a student of the Alliance Française de Paris and recipient of a scholarship for individuals in situations of exile funded by Galeries Lafayette, Groupe ADP, L'Oréal, and Kering, I commit to:

- Uphold the values promoted by the "Alliance Française de Paris" association and, as such, demonstrate exemplary civic behavior in accordance with French law and the Internal Rules of the Alliance Française de Paris,
- Attend regularly all classes and activities included in the scholarship program, funded by the Major Sponsors of the Alliance Française de Paris.

### 1- Respect for the Values of the Alliance Française de Paris

The Alliance Française de Paris is a non-political and secular organization. It welcomes all individuals regardless of ethnicity, religion, gender identity, or sexual orientation, bringing together people from diverse backgrounds in the same classroom.

I commit to fostering an environment where all students feel welcomed. I understand that no acts of physical or verbal violence, nor any form of discrimination toward other students or staff, will be tolerated.

I commit to respecting the values of the Alliance Française de Paris (respect, diversity, solidarity, tolerance, and intercultural understanding), as well as the premises and the resources made available to me.

### 2- Commitment

I commit to actively participating in the academic activities planned within the program and to fully engaging in the training. I also agree to take part in at least one cultural activity per month as part of the program. I will demonstrate a serious and responsible attitude within the institution and during class, particularly by bringing the necessary materials for the proper conduct of the course.

#### 3- Attendance

I commit to attending all scheduled classes in the program, to being punctual, and to observing break times. I agree to sign the attendance sheet at the end of each class I attend and to notify the institution in the event of an absence.

Unjustified absences must not exceed 9 hours (i.e., 3 days) per month under any circumstances.

## I understand that exceeding this threshold may result in the immediate revocation of the scholarship.

I also commit to following the training continuously and without interruption for its entire duration (4 to 8 months depending on the case). No voluntary break (vacation, personal projects, etc.) will be permitted.

# Any interruption will result in the permanent termination of the scholarship.

## 4- Image rights

I accept that my image may be used for communication purposes (group or individual photos, videos, quotes or testimonials) as part of promoting the program.

#### 5- Relationships with sponsors

As a scholarship recipient, I pledge to make myself available for meetings with the sponsors at the beginning, during, or at the conclusion of the programme. These meetings aim to provide an opportunity for me to share my journey, progress, and perspectives with the sponsors.

#### 6- Feedback

At the end of the program, I commit to completing a feedback form in order to evaluate the benefits of the training, share my experience, support future scholarship recipients, and contribute to the continuous improvement of the program.

## 6- Sanctions

The General Director of the Alliance Française de Paris is responsible for ensuring compliance with these rules. Any breach of this charter may lead to disciplinary action, up to and including withdrawal of the scholarship. In cases of serious misconduct, French law shall apply.
